BANK GUARANTEE

(To be provided on Rs. 100/- stamp paper)

1. In Consideration of the **Vydehi Institute of Medical Sciences & Research Centre (VIMS & RC), Bengaluru**, a private Medical College (hereinafter called "College") having agreed to provide admission to DM/MCh(subject) under **General** category allotted through Medical Councillng Committee (MCC), DGHS) to Dr.....S/o, (Hereinafter called "the said student"), a Bank Guarantee for performance of payment of the annual fees for remaining years of course payable by the said student is required.

2. We..... (Name & Branch of Bank) (hereinafter referred as "the Bank") at the request of(the said student) do hereby undertake to pay the college an amount not exceeding Rs..... against dues of annual fees payable to the college by the said student for the remaining **2** years for **DM/MCh** _____ (subject) Course under any of the following conditions : -

(a) When student fails to deposit the regular annual fee in the time-frame before last date of payment prescribed by the **Vydehi Institute of Medical Sciences & Research Centre (VIMS & RC), Bengaluru** as detailed below : -

(b) Incase When student has discontinued and not pursuing his studies due to any reason whatsoever, the entire fee for remaining years will be payable to **Vydehi Institute of Medical Sciences & Research Centre (VIMS & RC), Bengaluru**.

(c) When student has been rusticated due to misconduct or any disciplinary action or criminal act on his part, the entire fee for remaining years will be payable to **Vydehi Institute of Medical Sciences & Research Centre (VIMS & RC), Bengaluru**.

(d) In case of student not completing the above said Course in the prescribed time-frame student will pay additional fee for the additional period of studies in the college. These fees will be paid immediately, failing which the Bank guarantee will be cashed by the college.

- (e) We, the.....(Name & Branch of Bank) do hereby undertake to pay the amount due and payable under this guarantee without any demur merely on a demand from the college stating that the amount claimed is due by the said student. Any such demand made by the college on the Bank shall be conclusive as regards the amount due and payable by the Bank to the College under this guarantee. However our liability under this guarantee shall be restricted to an amount not exceeding Rs.....

- (f) We undertake to pay to the **VIMS & RC, Bengaluru** any money so demanded notwithstanding any dispute or disputes raised by the student in any suit or proceeding pending before any court of Tribunal relating thereto, our liability under this present being absolute and unequivocal. The payment so made by us for payment hereunder and the student shall have no claim against us for making such payment.
- (g) We, the (Name & Branch of Bank) further agree that the guarantee herein contained shall remain in full force and effective during the period that would be taken for the performance of the said Admission and that it shall continue to be enforceable till all the dues of the **VIMS & RC, Bengaluru** under or by virtue of the said Admission have been fully paid and its claims satisfied or discharged or till **completion of the course** and the college certifies that the terms and conditions of the said Admission have been fully and properly carried out by the said student and accordingly discharge this guarantee.
- (h) The Bank Guarantee shall remain in force up to **3 years**. Unless a claim is lodged with the bank within three months from the said date i.e. , this guarantee shall be forfeited and the Bank shall be relieved and discharged for all liabilities there under.
- (i) This guarantee will not discharge due to the change in the constitution of the bank.
- (j) We the (Name & Branch of Bank) lastly undertake not be revoked this guarantee during its currency except with the prior consent of the **VIMS & RC, Bengaluru** in writing.
- (k) However, in case of invoking this bank guarantee in the middle of the validity period due to default of payment of fee of any year by the student, the student is liable to produce fresh bank guarantee with the same amount for the remaining period of study.
